4.1 Board Composition

The other community vacant positions are in Division 5 and for the Millarville Racing and Agricultural Society (MRAS). Staff will reach out to both MRAS and MSA for representatives.

# 4.2 Next Phase

Previous discussions included the playground or various activity/gathering sites along the pathway and around the park.

J. Porter provided that the County's insurer does not have any issues with insuring natural playgrounds are covered as any other type of playground structure. If the construction and installation is completed by a qualified company as opposed to volunteers, there should be no issue with coverage.

The board previously discussed 5 potential projects:

- Multi-sport field
- Playground area
- Picnic/relaxation area
- Outdoor exercise area
- Interpretive signage along the pathway (local flora and fauna, features unique to the eastern slopes of the Rockies, and the Montane grassland areas)

There needs to be some refinement of where the board would like to proceed so high-level costing can be associated with those projects.

#### Comments included:

- Construction of playground by County may be limited to the placement of boulders. There would be no coverage for the County for the placement and intertwining of logs. This would need to be engineered.
- Natural playground along the pathway near bench sites for inventive play. Is a different focus than the playgrounds in the are.
- Consideration of use 7-8 months for high cost \$160,000+, perhaps smaller options should be considered.
- Consideration of the Plains Midstream pipeline. Any improvement will need to be mindful to avoid conflicts with the pipeline and future development.
- Tunnel? Culvert?
- Will the park considered to be a year-round park? during this last winter there was not significant use of the park. This may change over time.
- Identify the unusable area.

- Potential picnic table placement near the ball diamonds and the south side of the intersecting loop. Cautionary note on placement near the parking lot.
- Cost conservative.
- Picnic benches (unmoveable).
- Fundraising requires a plan.
- Low Maintenance.
- Bench Pads will be poured and the benches will be installed in the spring.

# 4.3 Open House

There was discussion regarding the change in direction and the need to inform the public with the new options on the conceptual design diagram that include the picnic area, natural stations, and interpretive signage.

# 4.4 Fundraising

Once the high-level costing is available there was interest in erecting a fundraising thermometer to be visible from HWY549.


