


#### WHAT WENT ON LAST WEEK?

On June 26, Foothills County RCMP located a northbound vehicle in the southbound lanes of Highway 2A while enroute to an unrelated call resulting in a roadside suspension and a 30 day vehicle seizure.

On June 26 Foothills County RCMP stopped a truck avoiding a checkstop at the High River Rodeo Grounds resulting in a roadside suspension and vehicle seizure.

June 26 Foothills County RCMP responded to several parking complaints on Plummers Road West at the Brown Lowery Provincial park. Due to being a road hazard, parking is not allowed on the road. Tickets will be issued to offenders.

June 26 Foothills County RCMP received a call to assist in locating two missing males swimming in the Highwood River. The males were located along the river before police arrived.

June 27 Foothills County RCMP attended a two vehicle collision southbound on Highway 2. A stolen pickup truck rear ended a semi trailer. Criminal charges have been laid against the driver of the stolen pickup truck.

June 27 Foothills County RCMP aided Calgary Police Service stop a vehicle which was being followed by HAWC. The vehicle was travelling south on Highway 2 when a stop was attempted. The vehicle was spike belted and followed to Tamerac Drive where 2 subjects were arrested. Criminal charges were laid by Calgary Police Service.

June 27 Foothills County RCMP attended a possible break and enter into a barn. The interior and exterior barn doors were left open by the intruders. Nothing was taken.

June 27 Foothill County RCMP received an online fraud complaint. The complainant purchased an item online, sent an e-transfer and never received the product. The seller is a fraudulent company.

June 27 Foothills County RCMP responsed to a break and enter east of Okotoks. The suspect entered through an unlocked man door to the garage.

June 28 Foothills County RCMP attended an alarm call in Heritage Pointe. The door to the business was unlocked. No sign of forcible entry or attempt of theft found and the alarm was deemed false.

June 28 Foothills County RCMP responded to a report of a stolen puppy. The complainant reported on social media about her stolen puppy. The puppy was returned and reported to have been found running loose by the person returning the puppy.

June 28 Foothills County RCMP responded to a theft of truck. The truck was located near Priddis stuck in the ditch. Police Dog Services attended but the trail was cold. No suspects.

June29 Foothills County RCMP received a complaint that three community mailboxes on Highway 2A near Okotoks were broken into. No suspects.

June 29 Foothills County RCMP received a complaint that the catalytic converters had been cut off of a Motor home while it was parked in storage. No suspects at this time.

June 30 Foothills County RCMP responded to a report of 6 suspicious vehicles which were going in an out of a construction site near Okotoks. RCMP attended and found it to be a grad party.

July 1 Foothills RCMP responded to assist with the retrieval of personal property and keep the peace between a common law partnership which was separating in Eden Valley.

July 2 Foothills RCMP responded to a complaint of a low flying aircraft near Plummers Road. RCMP noted that the week prior there was a notice of aerial spraying of crops going to happen this date at this location. Complainant advised.

July 4 Foothills County RCMP responded to two separate calls near Okotoks for stolen vehicles. Both files are still under investigation.

July 6 Foothills County RCMP responded to a call of computer fraud in the Millarville area. Investigation is under way.

July 9 Foothills County RCMP stopped a speeding motorist travelling on Highway 2 resulting in a roadside suspension and charges for no registration, fail to provide valid insurance and speeding.
