Proposed Redesignation.

I am writing to formally express my concerns regarding the proposed development of a Commercial dog & cat kennel in close proximity to our residence.

While I understand the importance of supporting local businesses and animal services, I am deeply concerned about the potential impact this facility may have on the surrounding neighborhood. One of the primary issues is noise. Dog kennels, by their nature, can generate frequent and unpredictable barking, which could significantly disrupt the peace and quiet that residents currently enjoy. This is especially concerning during early morning and late evening hours.

We already experience noise concerns from local dogs in the area where barking can be heard from a significant distance away. Having a kennel with a high volume of dogs, with even closer proximity, is especially concerning.

In addition, I am worried about the long-term effect this development may have on property values in the area. The presence of a kennel nearby may make homes less attractive to prospective buyers, potentially reducing resale value and making it more difficult for homeowners to sell in the future.

Our neighborhood has always been a quiet, family-oriented community, and we believe that this type of development is not in keeping with its character. I respectfully ask that the municipality carefully reconsider the location of this proposed kennel and take into account the concerns of nearby residents.
